In pursuance of cited ref, Applications are invited from the Eligible candidates for the post of Subsequent Director cum Dean at Bidar Institute of Medical Sciences, Bidar. The Minimum Educational Qualifications and Eligibility Criteria for subsequent Director cum Dean post shall be as per the MCI/NMC Norms, Cadre & Recruitment Rules and Bye-laws of Bidar Institute of Medical Sciences, Bidar.

### **Eligibility Criteria:**

#### **ACADEMIC QUALIFICATIONS AS PER MCI/NMC NORMS;**

1. Should possess the Recognized Post Graduate Medical Qualification and other Academic Qualification from Recognized Medical Institution with a Minimum of 10 years Teaching Experience as Professor/Associate Professor Reader in a Medical College/Institution, out of which at least 05 year should be as Professor in a Department.

#### **EXPERIENCE;**

2. Candidates for the said post shall be selected based on Seniority cum Merit for amongst the Teachers in the same Autonomous Institution i.e. Bidar Institute of Medical Sciences, Bidar.
3. 05 Senior most willing Professors as per the Seniority shall be considered by the Governing Council for the said appointment.

4. Candidates shall have Administrative Experience either as Medical Superintendent or as Head of the Department at least for 05 years.
5. Candidates shall satisfy Medical Council of India/National Medical Commission norms for appointment to the said post.
6. Maximum upper Age limit for the said post shall be 58 years as on the last date of Notification.

#### **ADDITIONAL CRITERIAS**

7. Candidate's Prescribed Probationary Period must have been declared as satisfactorily completed as per Karnataka Civil Services (Probationary) Rules 1977.
8. There should not be any criminal cases pending against the Applicant.
9. There should not be any Departmental enquiry pending against the Applicant.
10. All other eligibility criteria as specified in Bye laws of the institution & Government of Karnataka.

**Method of Selection:** The method of selection shall be on the basis of merit. The merit is assessed on the basis of the performances of the applicants and the marks obtained in the selection interview, as prescribed in Bye-laws of Bidar Institute of Medical Sciences Bidar. The Pay Scale: Rs 1,44,200-2,18,200 with applicable allowances as per Modified and revised AICTE Pay Scale for teachers in Medical Institutions under Govt. of Karnataka.

**Period of Appointment:-** Maximum Four years from the date of appointment or as Bye-laws of Bidar Institute of Medical Sciences, Bidar or until further Government Order whichever is earlier.


