# PURCHASE OF X-RAY MACHINES / RADIOLOGICAL EQUIPMENTS TO BRIMS TEACHING HOSPITAL, BIDAR.

When the Medical Council of India visited this institute on 18th and 19th Jan 2011 for inspection, they pointed out that C.T. Scan and X-ray Machines were not available in this institute and hence they did not renew permission for admission of 5th batch of students for the academic year 2011-12. At that time, the Government of Karnataka gave an undertaking to the Government of India, Ministry of Health & Family Welfare, New Delhi and to the MCI on 31-05-2011 that these instruments will be installed as per the MCI Norms early.

#### RESOLUTION:

After detailed discussion it was felt that the the X-Ray machines to the institute are the major requirements as per the MCI guidelines. The Director requested the Purchase Committee to approve the tender for the same.

#### The Purchase Committee observed that:

- (a) the rates that were quoted were comparable with the rates at which the company had supplied to other institutes (Private & Govt.) as evidenced by the supporting documents submitted by M/S FORESS HEALTH CARE LLP BANGALORE for Mobile 60 MA units, 300, 500 & 800 UNITS.
- (b) for 60 MA unit it was noted that M/s. ALLENGERS MEDICAL SYSTEM LTD., BANGALORE was the lowest bidder (L1).
- (c) for 300 MA Unit M/s FORESS HEALTH CARE LLP BANGALORE was the lowest bidder (L1).
  - (d) for 500 & 800 MA Units M/s FORESS HEALTH CARE LLP BANGALORE was the single eligible bidder. The rates were compared with the rates at which this company has supplied to other institutes. It was evident (with supporting documents) that the rates quoted were competitive & after negotiation (as mentioned above). The Purchase Committee authorized the Director, BIDAR INSTITUTE OF MEDICAL SCIENCES to place the subject before the Finance Committee and the Governing Council of the Institute for approval.
